- Be a **FULL or HONORARY MEMBER** of BSWA, eligible to vote, as must be the nominator and seconder.
- Note that if the BSWA Committee mandate Proof of Vaccination check, then Committee Members will need to comply with this requirement to attend our premises and fulfill their role on the Committee.
